
**ORDER NO. B4/10419/2015 (1) dated 09-09-2016**

As per Order cited 1<sup>st</sup>, excess specialist teachers of Kannur district under various categories have been clubbed with one or more schools. Certain representations have been received from the specialist teachers who have been clubbed with other schools to change their place of posting. Besides some Educational Officers have requested to retain some specialist teachers either in parent school by considering the strength of LP section or to retain teachers in existing schools as already clubbed by orders issued previously. Moreover it is noticed that, the specialist teachers in schools under corporate management were also included in the list

In the circumstances, after having considered all these facts in detail, the following modifications in the clubbing arrangement order issued as per the reference cited 1<sup>st</sup> is ordered with immediate effect as detailed in the Annexure appended. The corporate managers are directed to club the specialist teachers in schools under their educational agencies as per the direction contained in GO(P)29/2016/G.Edn dated 29-01-2016 and hence the name of specialist teachers under schools of corporate management are excluded from the list.

The Educational Officers are directed to verify the vacancies (clubbed school) mentioned in the annexure appended and to report discrepancies, if any, to the undersigned without delay.
